### **Qualification Purpose**

This qualification is designed for learners who are working in or preparing to work in food manufacturing or in food supply chain supervisory roles.

Ofqual purpose E. Updating and continuing professional development (CPD). Sub purpose E3.

Develop knowledge and/or skills relevant to a particular specialisation within an occupation or set of occupations.

Learners must be a minimum of 16 years old to take this qualification. Learners do not require any prior qualifications or experience to take this qualification, although achievement of a level 2 food safety or HACCP qualification may be an advantage to some learners. The qualification assesses and recognises achievement within a learning environment.

The qualification contains one mandatory unit covering principles of HACCP for food manufacturing. This is a regulated qualification.
